

New Zealand Certificate in Regulatory Compliance (Strands in Audit, Inspection, Investigation & Operations) (Level 5)

This qualification was designed to help further develop the specialist skills of senior regulatory compliance practitioners who carry out audits, inspections, investigations and/or operations.

Given the broad nature of the regulatory compliance field, a number of strands were developed for this qualification, to allow people to specialise in the areas most relevant to their roles.

This qualification will benefit local and central government organisations, and organisations that carry out regulatory compliance work on their behalf. This will be done by providing their staff the skills to operate in roles focussed on audit, inspections, investigations, or operations. Graduates of the programme will be able to operate independently in a range of situations within their functional area.

Typical Training Duration

6 to 12 months

- Demonstrate and apply knowledge of a risk-based approach to regulatory compliance activities
- Engage with stakeholders in a regulatory compliance environment
- Plan, manage, and review regulatory compliance activities

- Plan, manage and conduct, and evaluate interviews in a regulatory compliance context
